I affirm:

- 1 The document dated 1 December 20XX and signed in the margin by me and by the person before whom this affidavit is sworn is, I believe, the last will of Stewart Grimson late of Redfern, Teacher, the deceased, and I am not aware of the existence of any other document purporting to embody the testamentary intentions of the deceased.
2. My means of identifying the will are: the deceased was my father and I have seen him sign his name on many occasions. I recognise the signature on the will and identify it as the deceased's signature.
3. The attesting witness to the will is Jack Smith.
4. The deceased died on 18 April 20XX aged 59 years and I believe that the deceased is Stewart Grimson referred to in the certificate of registration of death which is annexed and marked "A".
5. The deceased did not marry after the will was made.
6. The deceased left assets within New South Wales.
7. I am not an undischarged bankrupt, I have not assigned or encumbered my interest in the estate of the deceased and I am over 18 years of age.
- 8 Jack Smith, the executor named in the will, died on 5 February 20XX as evidenced by the death certificate annexed and marked "B".
9. The names, ages and entitlements of the persons entitled in distribution of the estate are:
Rodi Grimson, 33 years, 50% share.
Arya Grimson, 26 years, 50% share.
10. The deceased was not married or in any other domestic partner relationship at the time of his death.
11. The deceased had two children:
(a) Rodi Grimson, who was born on 1 January 19XX. Annexed and marked "C" is the certificate of registration of birth of Rodi Grimson.
(b) Arya Grimson who was born on 1 February 19XX. Annexed and marked "D" is the certificate of registration of birth of Arya Grimson.
