We affirm:

1. The document dated 1 November 20XX and signed in the margin by us and by the person before whom this affidavit is sworn is, we believe, the last will of Isabella Rose, late of Redfern, nurse, the deceased, and we are not aware of the existence of any other document purporting to embody the testamentary intentions of the deceased.
